The benefit program ensures that adults and children who qualify for this need-based program have access to receive quality eve care through local VBA providers.

Participants in the Vision Benefit Program receive an exam, eyeglass frames and lenses from one of VBA's Participating Providers.

Adults and children residing in Pennsylvania who are underprivileged, distressed and live at 300 percent of poverty level or below

This year, Ann Silverman Community Health Clinic (ASCHC) is celebrating the milestone of serving greater Bucks County for 30 years.

With the goal of serving over 3,000 patients in 2024, ASCHC provides free medical and dental care, behavioral health and social services to low-income, uninsured residents of Bucks County.

## An Eye On Our Littlest Humans

2023 saw a significant increase in preschool vision screenings, reaching a total of 24,114 screenings.

According to the CDC, about 1 in 4 preschoolers have undiagnosed or untreated vision problems. Through these screenings, we are able to identify and address issues that may delay vision development or negatively impact learning at a much earlier age.

#### **Vision Screenings**

Kids often don't know if their vision is blurry. Vision screenings are a tool for simple-to-detect issues like nearsightedness or lazy eye. They identify children who need to see an optometrist or ophthalmologist for an eye exam.

Vision screenings do not result in a prescription. Instead, they may result in a referral for an eye exam.

#### Eye Exam

Eye exams are performed by an optometrist or ophthalmologist. Eye exams can help diagnose vision or eye health issues that may affect learning, development, play and future job opportunities.

Eye exams usually include an assessment of visual acuity, lazy eye, eye turns, 3D vision, eye tracking, convergence, color vision and overall eye health.

## Paving the Way For Student Eye Doctors

One of the most proactive ways to manage vision and general health concerns is by having yearly vision care exams. Did you know the next generation might not be able to access vision care as easily as you can today?

In the next decade, it's estimated there will be a 15% shortage\* of ophthalmologists nationwide. With a shortage in ophthalmologists, it's possible that not everyone will have access to the eye care they need.

The Pennsylvania Vision Foundation recognizes the importance of supporting the future of optometry and ophthalmology through investing in students.

We believe a quality education is the foundation of a well-rounded eye care practitioner. Providing an annual scholarship to a Salus University optometric student is an important part of serving our mission.

Through this endowed scholarship, we're ensuring a bright future for optometry in Pennsylvania.

## Spreading Kindness with Trucks for Maddox

In 2023, a \$25,000 grant was awarded to Children's Hospital of Pittsburgh Foundation at UPMC for exclusive use in the Trucks for Maddox Optical Assistance Fund. Since 2020, the Trucks for Maddox Optical Assistance Fund has worked to ensure that all children have access to the eyeglasses they need. Through this initiative, Maddox Derkosh's family is able to spread his legacy of kindness and friendship. With the Foundation's grant, 224 pairs of glasses were granted to children in financial need.



Programs like Trucks for Maddox mean so much to the family of a medically complex child. Braxton was fitted for his first pair of glasses. After taking the time to adjust to them. his caregivers saw an immediate improvement in his behavior. Now, he knows how to crawl, walk and play like other kids his age.

### **Meet Braxton**

Braxton was born with 7q11.23 duplication syndrome, a genetic disorder that can cause a variety of neurological issues, developmental delays and other conditions. One issue that was apparent early in his life was that he had both strabismus and intermittent exotropia of his left eye. These disorders mean his eyes do not line up in the same direction.

His caretakers Jamie and Tori were not able to address these disorders right away due to other life-threatening conditions. He was a toddler by the time he was physically stable enough for treatment for his eyes.

Children like Braxton who have these vision concerns may experience issues with depth perception that could delay certain developmental milestones like grasping for objects and crawling. Braxton's doctors explained that prescription eyeglasses would help improve his vision enough for him to achieve these goals and milestones. Jamie and Tori were initially relieved until they found out that their insurance did not cover eyeglasses at all.

After feeling defeated, Jamie contacted the eye clinic at UPMC Children's and learned about the Trucks for Maddox program.

Through Trucks for Maddox, Braxton was able to receive his first pair of glasses.
